## KEY CERTIFICATIONS CONSIDERATIONS FROM WWW.AUTOLIFT.ORG

- A lift must be certified.
- Certification extends to options and accessories.
- Use of a non-certified options or accessories voids the certification of the lift.
- Approved accessories are required to be listed for use by model number on ALI's Directory of Certified Products. Accessories not found on the Directory are not approved for use.

As important: Ask if an option (rolling jacks, forklift adaptors, etc.) is certified and adequately rated to lift the vehicle or perform the service intended or required for use (on the lift) with the specific accessory?

MOHAWK BELIEVES IN AN ADEQUATE CAPACITY RATING FOR ALL CERTIFIED OPTIONS.



- Mohawk offers 22" long forks to raise BOTH rear tires and not over pressurize the outer tire.
- **Ask:** How much do long forks de-rate certain lift brands?
- **Ask:** If the truck was engineered to go down the road on 4 tires on the rear axle, shouldn't it be lifted by all 4 tires?

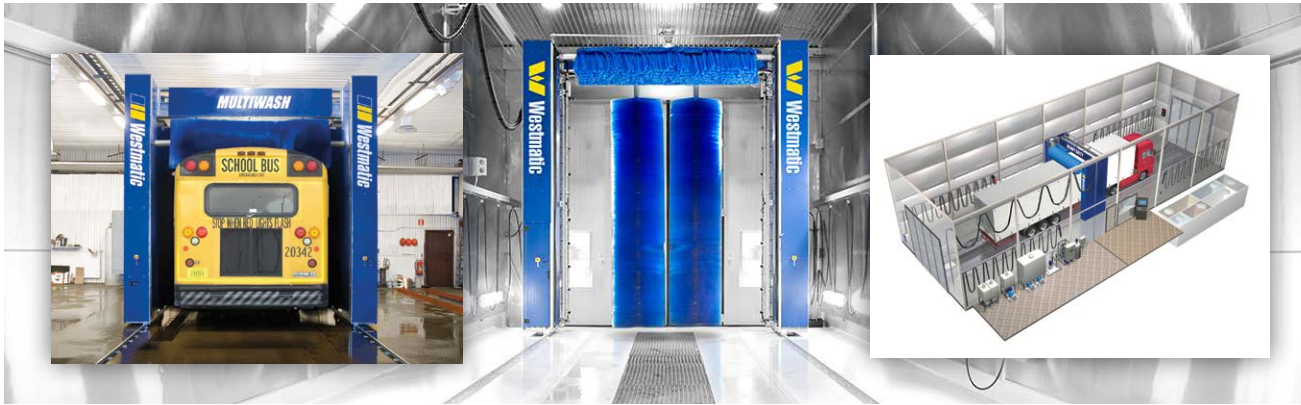
